



EXHIBIT R- RETAIL NURSERY PROVISIONS FOR THE INTRA QUARANTINED MOVEMENT OF REGULATED RETAIL NURSERY STOCK

- Establishment shall not move regulated articles out of the area quarantined for Asian citrus psyllid (ACP).
- Establishment shall only move regulated articles within the area quarantined for ACP when complying with all of the following:

1. Treatment for ACP

Establishment shall ensure all regulated articles are treated with a Project approved treatment in a manner specified below:

- a. Obtain plants already treated at production nurseries. Each treated plant must be received with a yellow tree tag (if received from a production nursery located inside the ACP quarantine area) or a blue tree tag (if received from a production nursery located outside the ACP quarantine area), or
- b. An initial treatment consisting of a foliar treatment and a drench treatment with a Project approved product. A list of approved products will be supplied by the Project.
 - 1) After treatment, a yellow tree tag must be affixed to each individual tree/plant. Each individual tree tag must include:
 - i. The statement: "This plant shall not be moved out of the area quarantined for Asian citrus psyllid."
 - ii. Reference to the California Department of Food and Agriculture ACP website: www.cdfa.ca.gov/phpps/acp/index.html
 - iii. A sequential tag #
 - iv. Name and address of the issuing nursery
 - v. Compliance agreement # of the issuing nursery
 - 2) Documentation of each treatment must contain the following information: date, product used (foliar and drench), # and type of each plant treated, tag # issued to each plant. An example treatment log is found on page 3 of this exhibit.
 - 3) Treatment documentation records must be retained on the premise for as long as the treated plants remain on site and for a period of at least two years after the plant is no longer on site, or
- c. An initial treatment of plants off-site in accordance with California Department of Food and Agriculture Master Permit QC 1228.

3. Tags for Regulated Articles

Establishment shall ensure that each regulated article has an affixed tree tag attesting that the plant shall not be moved from the area quarantined for ACP.

4. Public Information

Establishment shall periodically check the following website for current maps of the ACP quarantine area: www.cdfa.ca.gov/phpps/acp/index.html. Establishment may make these maps available to customers of host nursery stock to reinforce the quarantine requirement that host nursery stock may not be removed from the ACP quarantine area.

5. Infested Nursery Stock

If the nursery or any plant within the nursery is found to be infested with ACP, Establishment shall immediately notify the Project and not move any regulated articles from the Establishment until such time as the Project can determine that the nursery is free from ACP.
