SUBSIDIARY INFO –

Phyto is good for **30** days from inspection date. Split shipments (EX: a consignment that consists of more than one container, and for some reason the containers are shipped at different times) require a phyto for each separate shipment, or it will be refused entry.

SUMMARY INFO – Phytosanitary certificate required from all states except Florida, Hawaii & Puerto Rico. If fruit originates from Florida, Hawaii, or Puerto Rico, fruit is prohibited and an Import permit is required do not certify without one.

### FRUIT – (FROM CA)

Federal Phytosanitary Certificate Required for all hosts of Mediterranean fruit fly & Oriental fruit fly. (Citrus sp. is a host of Mediterranean fruit fly)

#### AD Required:

“The commodity in this shipment originated in an area within (county name) county of California which is not regulated for harmful species of fruit flies. Further, the commodity was subsequently safeguarded from exposure to harmful fruit flies.”

### PLANTS-including cuttings & unrooted cuttings

Import Permit and Federal Phytosanitary Certificate Required. State of origin must be indicated on the certificate.

- If shipping any other form of plant part please call the main office for Phytosanitary requirements.

### SEEDS –

Federal Phytosanitary Certificate Required. State of origin must be indicated on the certificate.

#### SUBSIDIARY INFO –

Phyto is good for **30** days from inspection date. The usual procedures inherent in the operation of quarantine regulated areas are sufficient to satisfy the safeguarding portion of the AD. Split shipments (for example, a consignment that consists of more than one container, and for some reason the containers are shipped at different times) require a Phyto certificate for each separate shipment or it will be refused entry.
