EUROPEAN UNION HAS CHANGED IMPORTANT PLEASE READ

The European Union countries have changed their Additional Declaration format. The New format is to be used from now on.

Users should see Additional Declarations in the following format:

- Example: *Consignment complies with Annex IV A 16.3 a of EC Plant Health Directive 2000/29/EC.*
- Any other Additional Declaration format, other than the example above, will not be accepted by the European Union, and will require correction and replacement of the certificate.
- The document *Additional Declarations for Bulbs, Corms, Rhizomes, Tubers, Plants for Planting, and Soil and Growing media*, for commodities not listed in a summary, has been uploaded to supporting documents.
- Users will need to use the current Additional Declaration glossary located in PExD under Supporting Documents (must select a EUN country), to determine the meaning of the Additional Declaration(s) listed in a summary.
- Any Phytosanitary certificates using the old format will not be acceptable and **SHOULD NOT BE SIGNED**. Signing such phyto may result in shipment being held on arrival.
- All phytos **MUST** have the Total Net Weight (in kilograms) listed in box 9 of the phyto, effective 4-01-14.
Example: 10 Cardboard Cartons Net Weight 250 kilograms _(commodity)_

GRAPES TO UNITED KINGDOM – There is a voluntary, SO₂/CO₂ verification, systems approach, program, for the control of black widow spiders, available for exporters to participate in during this shipping season. The California Table Grape Commission is responsible for coordinating this program. Exporters must register with this association and complete a compliance agreement. Compliance agreement procedures must be followed by the shipper. Shippers must have a tracking system and security system in place for all grapes in this program. All packaging shall be new Plastic, Styrofoam, or TKV type. Cardboard material shall NOT be used.

A treatment with 1% SO₂ & 6% CO₂ for 30 minutes is required. The pallets must have an SO₂/CO₂ treatment tag placed on them after treatment is completed. The treatment tag should have “treated with SO₂/CO₂” written on it, treatment number, and treatment date.

County personnel will review the logbook, treatment tags, & tracking procedures and will indicate compliance with the agreement by officially stamping each treatment tag, at the time of loading of the product into shipping containers.

ACOs should complete a shed inspection report

These inspections, which shall also be carried out on plants in the immediate vicinity of the nurseries referred to in Annex IV A 43 a shall be carried out at least by visual examination of each row in the field or nursery and by visual examination of all parts of the plant above the growing medium, using a random sample of at least 300 plants from a given genus where the number of plants of that genus is not more than 3 000 plants, or 10 % of the plants if there are more than 3000 plants from that genus,*
- *Have been found free, in these inspections, from the relevant harmful organisms of concern as specified in the previous indent. Infested plants shall be removed. The remaining plants, where appropriate, shall be effectively treated, and in addition shall be held for an appropriate period and inspected to ensure freedom from such harmful organisms of concern,*
- *Have been planted in either an unused artificial growing medium or in a natural growing medium, which has been treated by fumigation or by appropriate heat treatment and has been of any harmful organisms,*
- *Have been kept under conditions which ensure that the growing medium has been maintained free from harmful organisms and within two weeks prior to dispatch, have been:*
- *Shaken and washed with clean water to remove the original growing medium and kept bare rooted **or***
- *Shaken and washed with clean water to remove the original growing medium and replanted in growing medium Have been planted in either an unused artificial growing medium or in a natural growing medium, which has been treated by fumigation or by appropriate heat treatment and has been of any harmful organisms **or***
- *Subjected to appropriate treatments to ensure that the growing medium is free from harmful organisms, the active ingredient, concentration and date of application of these treatments shall be mentioned on the phytosanitary certificate*

AND

Consignment complies with Annex IV.A. I, **43 option (b) (bb)** of EC Plant Health Directive 2000/29/EC.

(Be packed in closed containers which have been officially sealed and bear the registration number of the registered nursery; this number shall also be indicated as an additional declaration on the phytosanitary certificate enabling the consignments to be identified)

AND SOIL/ GROWING MEDIA (APPLICABLE ONLY WHEN PRESENT)*****
