AD Required:

“The fruits have been grown and packed in an area not less than 80 kilometers from an area where any harmful species of fruit flies exists especially Mediterranean, Oriental, and Queensland fruit flies.”

If the above conditions of the AD cannot be met then the fruit must be cold treated. Fruit originating from regulated areas must be cold treated. The treatment section of the Phyto must be completed. Please phone the main office if information about this treatment is needed.

AD Required (for cold treated product)

“The products have been held in continuous cold storage at a temperature range between 32 degrees Fahrenheit and 34 degrees Fahrenheit for 14 days prior to export.”

Fruits & Vegetables which are fruit fly hosts require the above AD. If shipping vegetables, replace the word ‘fruits’ with the word ‘vegetables.’
