INSPECTION METHOD:

- 1. Establish the inspection unit: Total number of cartons to be shipped (inspection lot size) divided by the correct Biometric sample size (number of cartons) equals the 'sampling interval."
- Randomly select a number between 1 and the answer above ('sampling interval'). This is the number of the 1st carton to be selected for inspection.
- 3. To determine the 2nd carton, add the 'sampling interval' to the 1st carton number, the result will be the number of the 2nd carton to be sampled.
- 4. To determine the 3rd carton, add the 'sampling interval' to the 2nd carton number, the result will be the number of the 3rd carton to be sampled.
- 5. Continue this process until you have inspected the entire required 'biometric sample' number of cartons listed in the chart above.

PENALTY CLAUSE:

- A 'first 10 period' will be established for producers. This consists of the first 10 consignments submitted for inspection at the beginning of the season.
- During the 'first 10 period,' suspension/termination from the program (for the entire season) for a producer occurs when 3 separate consignments presented for inspection are rejected (per commodity, regardless of variety or cultivar).
- If the producer has a rejection rate of more than 25%, after 10 inspections, the producer will be eliminated for the season.
