*Importers must inform the above agency in advance of all aspects of shipments, dates, quantities, origin, volume, commodity, place of entry, means of transport, & any date requested, to evaluate any possible phytosanitary risk. The above agency will provide interested parties with phytosanitary import accreditation forms. These forms properly completed and signed must be returned to the above agency and the latter, once it has gathered the opinion of its technical department and other Ministry of Agriculture divisions will grant the corresponding phytosanitary import accreditation. This application must be delivered well ahead of shipping time. Contact this agency for details.

SEED – Import Permit and Federal Phytosanitary Certificate required.

AD Required: “XANTHOMONAS CAMPESTRIS PV. CITRI is not known to occur in the United States.”

PLANTS & PLANT PARTS – Import Permit and Federal Phytosanitary Certificate required. Must be free from *Spiroplasma citri* (=citrus stubborn), citrus tristeza virus, *Radopholus citrophilus*, *Xanthomonas campestris pv. citri*, *Deuterophoma trachelphila* (Citrus mal secco), and Citrus greening disease MLO. The plants must be derived from a line of material under a certification plan requiring them to be maintained under appropriate conditions and submitted regularly to official analysis using appropriate tests or methods.

AD Required: “The nursery where the plants were produced is under a program of official inspection. The plants have undergone appropriate tests or methods and found free of SPIROPLASMA CITRI, and Citrus tristeza virus. The plants are free from RADOPHOLUS CITROPHILUS. XANTHOMONAS CAMPESTRIS pv. CITRI, DEUTEROPHOMA TRACHELPHILA, and citrus greening disease MLO are not known to occur in the United States.”
