Dear Licensee,

All licensed individuals and companies that intend to operate and do business in Kern County are required to register on an annual basis with the Department of Agriculture and Measurement Standards. All **2012** registrations expire December 31, 2012. Before performing any work in Kern County for calendar year 2013, you must first be registered. The Department will begin the **2013** registration process on December 10, 2012.

Hours for registration will be Monday through Friday, 8:15 a.m. to 11:30 a.m. and 1:15 p.m. to 4:30 p.m. We are sorry, but no one will be available between 12:00 noon and 1:00 p.m. to complete your registration.

Please be sure you bring the following items with you at time of registration:

**Pest Control Operators** - must be the Qualified Applicator License holder - may register by mail **if not** using Restricted Materials

- Valid Picture ID
- Current Qualified Applicator License
- Current State Business License
- Current Equipment List
- Current Medical Supervision (if you use Organophosphates or Carbamates)
- Registering by mail - you **must** include a letter stating you will not be using Restricted Materials and a completed form (PR-PML-059) from your nearest Agricultural Commissioner's Office
- Fee is \$50.00 per location

**Maintenance Gardeners** - must be the Qualified Applicator Certificate holder

- Valid Picture ID
- Current Qualified Applicator Certificate
- Current State Business License
- Fee is \$25.00

**Pest Control Adviser** - may register by mail

- Valid Picture ID
- Current Pest Control Adviser License
- Fee is \$10.00 if Kern County is your home county; \$5.00 if you are already registered in another county (include completed form PR-PML-091)

**Structural Pest Control Operators - Branch 1** - a responsible person must register in person

- Valid Picture ID
- Current Structural Pest Control Board Company Registration
- Current Operator License
- Fee is \$10.00

**Structural Pest Control Operators - Branch 2 & 3** - may register by mail

- Valid Picture ID
- Current Structural Pest Control Board Company Registration
- Current Operator License
- Fee is \$10.00

**Agricultural Pilot** - may register by mail

- Valid Picture ID
- Current State Pilot License
- If you are an apprentice, you must have a journeyman to supervise you
- Fee is \$10.00 if Kern County is your home county; \$5.00 if you are already registered in another county (include completed form PR-PML-091)

**Farm Labor Contractor** - must be the license holder - may register by mail

- Current Farm Labor Contractor License with picture **or** letter from Department of Industrial Relations verifying that you are currently licensed with a valid picture ID
- If registering by mail you must also include a copy of a current 2013 registration from another county
- Fee is \$25.00

Registrants that are eligible to register by mail must include all required documentation and appropriate fees. This includes a completed form (PCO Form Number PR-PML-059, PCA Form Number PR-PML-091, and Pilot Form PR-PML-009) from your nearest Agricultural Commissioner's Office. **Forms are now available on our website [www.kernag.com](http://www.kernag.com).**
